Item No. 26.01.01 Reduction in intake of UG B.E (ECE) from 180 to 120 already approved by Academic courses- Clarification on category

The department of ECE had 180 intake for B.E, ECE (one batch of 60 students under regular and two batches (60+60) students under self - supporting). In order to maintain the faculty- students ratio at the prescribed values of the AICTE for the purpose of accreditation the department has requested for reduction in intake from 180 to 120 via., the minutes of 21st DCC of DECE, dated: 09.11.2020. This reduction was approved by the academic courses via Letter No.0713/AU/CAC/2021 dated: 09.03.2021.

The reduction of intake does not mention the category of reduction such as Self supporting or Regular. This is placed in the DCC for clarification. After discussion it is decided that, one batch of 60 students under self supporting scheme may be dropped, and it is recommended that the intake of B.E ECE programme will be 120 composed of one batch of 60 regular students and another batch of 60 self supporting students.
