# 1. Approval of Internship and advancement of courses of Eighth Semester of B.E. / B.Tech. Programmes regulation 2012.

R.Hemachandar (2013506075) & R.Remo Antony (2013506096) 6th semester B.Tech Students has got Internship in M/s.PAYPAL. DCC approved that the students can undergo 6 months Internship as per regulation 2012 and they can be permitted to advance two elective courses of eight semester to 6th and 7th semester respectively. Accordingly they have selected the 8th semester elective Cyber Forensics in 6th Semester and Mobile application development in 7th Semester.
